

Justice For Children and Youth

Justice For Children and Youth or JFCY is a non-profit specialty legal clinic funded by Legal Aid Ontario that works to protect the rights of children and young people facing conflicts with the legal system, education, social service or mental health systems.



CHILDHOOD ARRIVALS SUPPORT & ADVOCACY

- CASA serves young people who were brought to Canada as children and yet are living in Ontario without immigration status.
- CASA provides:
 - Legal representation
 - Trusted intermediary supports
 - Outreach and public legal education
- Our service delivery is free, confidential, and recognizes the complexity of the barriers for young people without status (and their families)

Our focus today:

- 1. How can we create more inclusive, accessible, and supportive schools for young people with precarious or no immigration status?
 - a. How can educators support these young people in their classrooms?
 - b. How can educators incorporate this topic in their lesson plans in an engaging and curriculum-linked way?

What is precarious immigration status?

- Precarious immigration status refers to individuals who are not citizens or permanent residents, specifically anyone who does not have full legal status in a country.
- There are many different state-defined legal status categories.
- There are many different ways someone can have precarious or no immigration status.
- Status is not static.

Who are young people with precarious immigration status?

- Arrived in Canada at a young age and living most of their lives with precarious or no immigration status
- Don't always fit into the category of "newcomers"
- Can be present in any and all classrooms
- Not everyone is aware of their status or lack of status

Impact of Immigration Precarity

- Precarious status can negatively impact:
 - Access to healthcare
 - Access to legal employment
 - Access to education
 - Mental health
 - Identity
- How do these barriers manifest in school settings?
- What impact do they have on education outcomes?

How can educators support these young people in their classrooms?

Scenario 1

A young person named Jacob wishes he could be part of the soccer team at school, but as a young person without immigration status, he is worried about his status.

Scenario 2

Janu is receiving excellent grades in Grade 12. They are being encouraged by their teachers to pursue scholarship and apply to prestigious universities. Janu avoids these conversations because of their immigration status.

OPTIONAL: Scenario 3

Alice is a Grade 9 student who has grown up knowing about their lack of immigration status. In Grade 9 Geography, the class is discussing migration to Canada. Another student says "All illegal immigrants should get sent back to their own country. You should only come into Canada the proper way." Alice stays silent but is feeling nervous and ashamed because of her lack of status in Canada.
