AGREED STATEMENT OF FACTS

- 1. The Crown and Defence have reviewed an autopsy report conducted on Avery Lee conducted by Dr. Lancel Elliott, M.D. and accepted as fact that Avery Lee's death was caused by blunt force trauma, likely caused by a single hard blow to the chest by a large, circular object.
- 2. The Crown and defence have reviewed and accepted a DNA analysis from the provincial forensics science centre which concluded the following:
 - a) The blood on Rayne Gomer's green turtleneck contains mixed DNA from Rayne Gomer and Avery Lee.
- b) Due to an error in the processing of Rayne Gomer's pants, no conclusion was available as to DNA in the blood on the pants. The large stain on the pants is dirt, not blood.
 - c) The blood on Rayne Gomer's shoes contains DNA from Rayne Gomer alone.
- 3. It is agreed that a Corbett application was made and it was held that Gomer could be cross-examined on their complete criminal record if they testified at trial. Gomer has been convicted of one criminal offence, an aggravated assault originating on June 12, 2015. The charge was domestic in nature (relating to domestic violence), stemming from an altercation with their then-partner whom they lived with at the time. The victim had documented bruising around their left eye and left side of their cheek. The victim required no immediate emergency medical attention. No weapon was used. Gomer was sentenced to 45 days in custody with a 14 month long probation period, with reporting requirements and orders not to contact the victim or go within 250 metres of their residence. Gomer completed their probation period without reoffending or violating the terms of the probation order.
