## Elder Jan Kahehti:io Longboat, Turtle Clan of the Mohawk Nation

Jan Kahehti:io Longboat, Turtle Clan of the Mohawk Nation, is an Elder, educator, writer, herbalist, cultural advocate, and visionary, having dedicated her life to the dissemination and learning of Indigenous language and culture. Longboat ran a ten-year program called Idawadadi, which won the Aboriginal Healing Foundation's best practices award and an outgrowth project entitled Dotah's House to assist Indigenous women survivors to heal from the abuse of Residential Schools while strengthening their communities through cultural knowledge. Frequently called on as a counselor, committee and board member, Kahehti:io has served on the Centre for Indian Scholars and Association of American Indian Physicians, Chiefswood National Historic Societies Board, Six Nations Elders Council, Kanatsiohare:ke Mohawk Community, the Children's Aid Society of Brant, among others.

Longboat continues to serve as a board member at the St. Michael's Hospital Well Living House project in Toronto as well as the on the Elders' councils at the University of Toronto, Enaahtig Healing Lodge and Learning Centre, and the Native Canadian Centre of Toronto.

Jan Longboat is currently an Elder Advisor to the Ministry of Justice: Indigenous Peoples' Court in Brantford. She taught at Mohawk College, McMaster University, and the University of Toronto and has worked with several Indigenous health centres including Wabano, Desdwadadesnye, and SOHAK. Kahehti:io received her degree as a Natural Health Practitioner from the Canadian College of Natural Medicine and received a degree in counseling from Laurentian University. She continues to live, teach, write, and garden on the Six Nations of the Grand River, where she was born and raised.



#### Justice Catrina Braid, Superior Court of Justice, Kitchener

Justice Braid graduated in 1994 with both a B.A. in psychology from Brock University and an LL.B. from Osgoode Hall Law School. She started her legal career at a litigation firm in Waterloo where she had a varied practice including criminal defence work, family law, civil litigation and standing agent work for the Federal Crown. In 2000, Justice Braid took a permanent position as a drug prosecutor. She worked as a Federal Crown in Toronto and Kitchener. Justice Braid was appointed to the Superior Court of Justice in 2014. She presides in family, civil and criminal matters in Kitchener, Ontario.



#### Jennifer Bolduc, Senior Counsel

Jennifer began her career in Thunder Bay, Ontario with a full-service law firm but ultimately returned to Southern Ontario and commenced work in the Waterloo Region in 2014. After working for two local firms where she developed a stellar relationship with her fellow lawyers and the courts, Jennifer joined Musson Morneau LLP in September 2022 as Senior Counsel. Her practice is solely in the area of family law including being a panel lawyer for the Office of the Children's Lawyer. In addition to being the current Chair of the Family Lawyers of Waterloo Region, Jennifer is a member of The Advocates' Society, the Family Lawyers Association, Collaborative Divorce of Waterloo Region, the Waterloo Region Law Association, the Ontario Bar Association, and the Canadian Bar Association.

Jennifer currently sits as a Trustee with the Waterloo Region Law
Association and sits on numerous WRLA committees including the
Continuing Development Committee, The Equity, Diversity, and
Inclusion Committee, the Golf Committee, and is the Chair of the Unified
Family Court Bench and Bar Committee. She also sits as a representative
on the Courthouse Child Protection Committee and the Courthouse
Community Resource and Liaison Committee which works to bring
together stakeholders around the Region to identify and improve family
law and associated services. Jennifer has been an active volunteer in
the Ontario Justice Education Network's Waterloo Braiding Diversity

program which aims to connect marginalized and/or racialized young women (cis and trans) in high school with women working in the legal sector. Jennifer is currently Chairing the development of Braiding Diversity 2.0, a program geared towards post-secondary students.

Jennifer grew up in Southwestern Ontario before obtaining her B.A. in English Literature from Kentucky State University on a full fastball scholarship in 2006 (summa cum laude), graduating from the University of Ottawa Faculty of Law in 2009, and was Called to the Bar in 2010.

In her spare time, Jennifer enjoys playing hockey and fastball as well as attempting to keep up with her dogs on their walks.



#### Mara Clarke, Family Lawyer

Mara Clark started her legal career in the areas of securities and corporate law, upon being called to the Bar. In 2008 she returned to her social justice/public legal education roots when she joined the outreach team of Ontario Justice Education Network. In her role as Director of Outreach, Mara was responsible for managing the team that taught vulnerable youth about the law. In this role, Mara designed family law public legal education programs for some of Ontario's most vulnerable mothers. Through this challenging work, Mara found her passion: family law.

Mara's settlement focused, culturally sensitive approach to family law practice prioritizes her client's interests and the parties' relationship. This helps establish the "new normal" that will guide their interactions moving forward. At times, the assistance of the court is required to settle matters. #### Rebecca Currie, Kitchener Probation and Parole

Rebecca holds a Bachelor Degree in Social Development Studies and an Honours Degree in Social Work from the University of Waterloo. Rebecca commenced her employment as a Probation & Parole Officer in 1998 and has worked in Kitchener and briefly in Hamilton. Rebecca has also had the opportunity to complete developmental assignments as a Social Worker at the former Guelph Correctional Centre and as a Victim Witness Services Worker at the Victim Witness Assistance Program at Kitchener Court.

Rebecca has predominantly supervised specialized case loads such as Sex Offenders, Intensive Supervision/High Risk Offenders, Guns and Gangs, and Prolific Offenders. Her current duties include supervising offenders placed on conditions by the Court or the Ontario Parole Board, completing assessments, writing court reports, and liaising with various community resources as well as the police.

Rebecca has had the opportunity to participate in a number of committees including Aftercare, Forensic Mental Health, Employee Health and Productivity, and Guns and Gangs. Rebecca is an active union member of the Ontario Public Service Employees Union (OPSEU) and sits on the executive of her local branch.



## Ross Denny-Jiles, Superior Court Judicial Law Clerk

Ross graduated from Queen's University with a joint JD/MPA (Masters of Public Administration) in 2022. Upon graduation, he received the Dean's Key Award for best embodying the signature values of Queens Law: community, collegiality, professionalism, service, exemplary commitment and responsibility towards legal studies, and academic achievement. Originally a theatre major at the University of Southern California (USC), Ross transferred to Quest University Canada in Squamish, BC, where he completed a Bachelor of Arts and Sciences, studying the relationship between equality and democracy.

While at Queen's, Ross became the first Queen's Law student to ever serve two terms as President of the Law Students' Society (LSS). As President, Ross represented his classmates on the Queen's Law Faculty Board, the Law Students' Society of Ontario (LSSO), and the Queen's Society of Professional and Graduate Students (SGPS). He helped

successfully advocate for the de-naming of Sir John A. MacDonald Hall and established a multi-faith prayer room within the law school. #### Raffi Dergalstanian, Superior Court Judicial Law Clerk

Raffi received his J.D. from Western University in 2022. Prior to commencing his law degree, he graduated from the University of Toronto with a Bachelor of Applied Science in chemical engineering.

Prior to law school, Raffi worked as a technical analyst at IBM and as a project manager at Polydex Pharmaceuticals.
